quadern gris josep pla epub download trials by the state shall be held by the court before a commissioner of the county or by the commissioner of the county before a justice of the peace in the county where the alleged violation of any law of this state occurred. If the county or justice of the peace does not or cannot hold the trial within one hundred and sixty days from the date of the order of transfer, the order of transfer shall be set aside and the papers returned to the appropriate court. If the defendant is not a resident of the county and was sentenced to a county jail, he shall be returned to the proper county for trial as provided in this section. If the defendant is not a resident of the county, or the county is not the proper county, the defendant shall be delivered to the sheriff or police chief of the county where the offense was committed for delivery to the sheriff or police chief of the county where he was sentenced to serve the balance of the sentence. The sheriff or police chief of the county where the defendant was arrested shall have the authority to receive the defendant for the return to the court in which the case originated. If the defendant was sentenced to serve a jail sentence, and is committed to a jail in another county, the sheriff or police chief of that county shall have the authority to receive the defendant for the return to the court where the case originated. If the defendant is a minor, the court may order him to be delivered to the appropriate agency for care and custody. If the defendant has been returned to the court for trial, the judge may enter an order setting the case for trial or continuing it from time to time as the judge may deem appropriate. If a trial has not been held within seven months of the date on which the defendant was arrested, the defendant shall be discharged and released from any and all further custody, except the custody attendant to a charge of a subsequent offense. If a trial has been held within seven months of the date on which the defendant was arrested, the court shall enter an order, if it so determines, discharging the defendant and releasing him or her. Such an order is appealable to the criminal court of appeals of the county. The magistrate must also determine whether the defendant is competent to proceed at such a trial and whether the court has jurisdiction of the offense and of the defendant. If the defendant is incompetent, the magistrate must order the defendant committed to a state mental institution. If the defendant is found competent, the magistrate must determine whether the defendant has waived the
